

July 02 Deadline for prospective minor parties to file party formation petitions with the Secretary of State (126 days before election)
July 18 Nominating petitions of minor political party candidates (for minor party that submitted party formation petition) must be filed (110 days before election)
August 7 Nominating petitions of independent joint candidates for president and vice president must be filed with the Secretary of State by 4 p.m. (90 days before election)
August 26 Write-in candidates must file declarations of intent by 4 p.m. (72 days before election)
