

If you couldn't guess, the answer is *all of them*. We know that the day is long and oftentimes boring, but we must *insist* that you not only keep political conversations away from voters but also from other Precinct Election Officials. Each scenario above was reported to us, sometimes by voters, sometimes by other PEOs and occasionally by both. By law, we cannot allow political conversations in polling areas.


