Primary Election Information

This is a Primary Election; voters will decide which Party Ballot (Democratic/Republican) they would like or an Issues Only Ballot, if available. There are not issues in every precinct.

- When a voter requests a political party ballot, this is the political affiliation the voter will have until the next Primary Election.
- If the voter wants an Issues Only Ballot, they will not be affiliated with a party.
- If a voter wants to switch political parties, they are free to do so. In **VERY** rare cases, if a PEO has direct knowledge that the voter is switching parties and does not support that party, then they could be challenged by voting a Provisional Ballot.

17-Year-Old Voters

- A 17-year-old voter can vote in Primary Elections IF they previously registered to vote 30 days prior to the Election. They can not vote on issues, only candidates. If you have any of these voters, you will have special ballots and there will be a special note in the Blue Voted Ballot Bag with additional instructions.
- The ePollbook will clearly identify 17-year-old voters by displaying a message.
- There will be special Democratic and Republican ballots in your bag labeled 17-year-old ballots. This ballot has a
 barcode and will be scanned to the voter's record.
- Process in the appropriate Green with a Driver License or Yellow line with other ID.
- If a 17-year-old comes in who is not registered to vote- they should vote provisionally and can use a regular ballot.

Green/Yellow Line

The ePollbook Station consists of the Green and Yellow Lines. The Greeter sends the voter to the correct line.

Send voters to the Green Line for:

Valid Unexpired Ohio Driver License or State ID

Send voters to the Yellow Line for:

- Valid IDs (Temp BMV, US Passport, US Military, Ohio National Guard, US Department of Veteran Affairs)
- Invalid Ohio Driver License or Ohio State ID
- Expired Ohio Driver License or Ohio State ID
- Incorrect Name (name change) in ePollbook
- Incorrect Address (address change) in ePollbook
- Voting Regular Ballot with Physical Accommodations
- ePollbook Indicated Provisional (Acknowledgement Card Returned Undeliverable or Requested an Absentee Ballot)
- Soiled or Defaced Ballot
- When not processing voters, help process Green Line Voters

Provisional Specialist Training

The Yellow Line is designed for any voter who presents with anything other than a valid, unexpired Ohio Driver License or State ID. These voters are further grouped into Provisional and Regular according to their specific situation. It is possible, the voter could have a combination of situations.

A Provisional Voter presents with:

- Invalid Ohio Drivers License or Ohio State ID
- Expired Ohio Drivers License or Ohio State ID
- Incorrect Name in ePollbook
- Incorrect Address in ePollbook
- Provisional Voter Statement in ePollbook

A Regular Voter presents with:

- Valid ID other than Ohio Driver License
- Name Change with Proof
- Voting Regular Ballot with Physical Accommodations
- Soiled or Defaced Ballot

These voters often require more time and we want to separate them from the faster moving Green Line.

Yellow Line Situation - Voters with Regular Ballot

Voters with a Valid ID (other than Ohio Driver License ID)

- Ohio Temporary Drivers License
- US Passport or Passport Card
- US Military, Ohio National Guard, and US Department of Veterans Affairs

Hint:

When entering a voter's name do not use a hyphen


