A Majority Affirmative Vote Is Necessary For Passage.

Shall a levy be imposed by the Little Miami Local School District, Counties of Warren and Clermont Counties, Ohio, for the purpose of PROVIDING FUNDS FOR CURRENT OPERATING EXPENSES, in the sum of \$490,000 per year and a levy of taxes to be made outside of the ten-mill limitation estimated by the county auditor to average nine and thirty-two hundredths (9.32) mills for each one dollar (\$1.00) of valuation, which amounts to ninety-three and two tenths cents (\$0.932) for each one hundred dollars (\$100.00) of valuation, for a period of five (5) years, being the tax years 1979, 1980, 1981, 1982 and 1983.
