- I understand that if an absentee ballot is mailed to me and I change my mind and go to my polling place to vote on Election Day, I will be required to vote a provisional ballot.
- I understand that if I do not provide the board with all of the required information, my application cannot be processed.
- I hereby declare, under penalty of election falsification, that I am a qualified elector and the statements above are true.

TO ENSURE YOUR ABSENTEE BALLOT REQUEST IS PROCESSED, PLEASE DO THE FOLLOWING:

1. **FOR PRIMARY ELECTIONS ONLY:** Make sure you have filled in the type of ballot you are requesting.
For example choose "Political Party Ballot" and fill in your desired party or choose "Issues Only Ballot." (section 7)
2. **FOR SPECIAL AND PRIMARY ELECTIONS:** Ensure "Date of Election" (section 7) lists the date of the election for which you are requesting a ballot, NOT today's date. *(Date not required for General Elections)*
3. Check that all required fields are complete.
4. Print, sign, and date your form.
5. Mail the completed form to your county board of elections. We are prohibited by law to accept faxes and emailed applications. We must receive the original form. OR drop off your form at our office. We have a 24-hour monitored drop box.

NEXT STEPS

Once your absentee ballot request is received by our office, we will promptly process your request and mail your ballot to your address. *(Ballots are not mailed out until 29 days before the election)*

Once you receive your ballot, to ensure your ballot is counted, it must be received by the Warren County Board of Elections by 7:30 p.m. Election Day OR be postmarked the Monday before the election and delivered by mail to our office no later than 10 days after the election.

The U.S. Postal Service (USPS) estimates that it may take two to five days for your voted absentee ballot to be delivered to our office by mail.
